DISCLOSURE OF INSIDE INFORMATION

Pursuant to and for the purposes of Article 17 of Regulation (EU) No. 596/2014 of the European Parliament and of the Council of 16 April 2014 (Market Abuse Regulation), and Article 29-Q of the Portuguese Securities Code, Estoril Sol, SGPS, S.A. (“Estoril Sol” or the “Company”) hereby discloses the following inside information:

On 29 April, the Issuer published an inside information announcement stating that it would be unable to comply with the legal deadline for the disclosure of its consolidated financial statements for the financial year ended 31 December 2025, estimating that the process would be completed within the following three weeks.

However, despite the efforts undertaken by the Company’s management and all other parties involved, it will not be possible to meet such extended deadline. This delay results mainly from two factors: firstly, the complexity associated with the effects arising from the termination of the Póvoa Casino Concession and, secondly, the updated recognition of the impairment value relating to the gaming concessions in Estoril and Lisbon, held by the subsidiary Estoril Sol (III) – Turismo, Animação e Jogo, S.A.

The Board of Directors estimates that it will be in a position to disclose the required information by 22 June and regrets the delay.

The Company shall disclose any additional relevant information related to the matters referred to in this announcement, pursuant to Article 17 of the MAR and Article 29-Q of the Portuguese Securities Code, whenever deemed appropriate.
